The City of Orlando District 3 in Orange County, Florida contains municipal precinct OL47.

Municipal precinct OL47 approximately extends north along Glenridge Way and Corrine Dr, east along Lakemont Ave, Meeting Place, Common Way Rd, Bennet Rd and Fern Ave, south along Colonial Drive, and west along Bumby Avenue. Within these borders are many sections which are considered unincorporated Orange County, and not part of the City of Orlando. This municipal precinct also includes the following Orange County precincts:

The polling place for OL47 is located at Emmanuel Episcopal Church, 1603 E Winter Park Rd.

Emmanuel Episcopal Church is situated between Winter Park Rd and Raven Rd in precinct OL47.

Each listed Orange County precinct is partially made up of the City of Orlando and partially unincorporated Orange County, which change according to municipal annexation ordinances.
